Working Group Reports

Solar Working Group Update

Allison has been working to collect information about the solar project from Vince, Eric Bornemann and Mike from Hardwick Electric. An additional program, called Tigo, is being used to monitor the system. There have been some discrepancies between our solar production and electrical usage and what Hardwick Electric is reporting to us. There were some panels that were not working properly this fall. After some troubleshooting a simple repair of a tripped breaker was performed, but the cause of the tripped breaker is currently unknown. It has also been hypothesized that the angle of the panels and snow cover are affecting the panels' ability to harvest energy, but it was also pointed out that this has been a particularly difficult autumn for solar production.

Books for Babies

Misty asked about distributing books to a local family that plays a large role in the community.. The board supported this proposal.

Annual Appeal Thank You Letters

Susan distributed materials to board members to write thank you notes to all annual appeal donors.

Meeting Time Change
